This year there will be an additional class offering, Police 'D' or Electrical Diagnostics. Additionally, all of the course curriculums have been revised to bring the content of Police Technical Training Classes closer to the Professional Harley-Davidson Training received by dealership technicians. Students will be evaluated on their ability to perform the required procedures.

Courses are now structured to be attended in the following order: Police 'A,' Vehicle Maintenance; Police 'D,' Electrical Diagnostics, Police 'B,' Power Train Service; and Police 'E,' Engine Management Systems. There is no prerequisite for Police 'A'; however, Police 'A' is required for Police 'D,' Police 'D' is required for Police 'B,' Police 'B' is required for Police 'E'. (If you have attended Police I and II in previous years, this fulfills the Police 'B' requirement.)

## **Course Descriptions**

#### POLICE 'A' VEHICLE MAINTENANCE

This course is based on the needs for routine, scheduled maintenance of Harley-Davidson Police Model motorcycles. The skills needed to perform maintenance that meets Harley-Davidson specifications are often taken for granted and require complex and diverse skills. This course is designed to offer participants a "hands on" introduction to all aspects of routine, scheduled maintenance. Upon completion of this course, participants will perform a wider variety of maintenance tasks more efficiently and to Harley-Davidson specifications.

Tasks include the complete 10,000-mile service procedure.

No Prerequisite Tuition: \$549

#### POLICE 'D' ELECTRICAL DIAGNOSTICS

This course concentrates on the fundamentals of electrical charging, Ignition, and starting systems. As new technologies are used in Harley-Davidson police motorcycles, electronics play an ever-increasing role in the proper functioning of the motorcycles' various systems and components. Participants will learn to use a Scanalyzer to properly diagnose and properly correct abnormalities in the motorcycles electrical systems. The course includes design and function, proper system set up and adjustment. Basic electrical fundamentals will also be reviewed.

Students will also receive instruction in the proper installation of Emergency Response Equipment (Emergency Lighting and Siren Systems) and be introduced to the new Emergency Equipment Systems designed specifically for Harley-Davidson police motorcycles.

Prerequisite: Police 'A' or Police I Tuition: \$549

#### POLICE 'B' POWER TRAIN SERVICE

This course will present an overview of the design and function of the 1450cc engine and transmission, including clutch assembly. Portions of this class involve sound diagnosis of abnormalities within the engine and transmission. Participants will work in teams diagnosing "noises" indicative of various problems on "bugged" motorcycles. The instructor will coach the participants, to develop and improve their diagnostic skills. After the engine noises are diagnosed, the participants will disassemble the engines and verify the problem(s) found.

Tasks include engine removal, disassembly, component identification, reassembly and installation. Please be aware: This is an advanced course. Prerequisite: Police 'D' Tuition: \$549

#### POLICE 'E' ENGINE MANAGEMENT SYSTEMS

This course will introduce the technician to the Delphi Electronic Fuel Injection System used in Harley-Davidson police motorcycles beginning with the 2002 model year. Students will acquire the skills to properly maintain, diagnose and repair abnormalities in the E.F.I. System,

# **Return to Harley**



# Elmhurst Police Department

The Elmhurst Police Department has a rich history and exemplary tradition of incorporating motorcycles into its daily operations. The City of Elmhurst is a suburb of Chicago with a residential population of 45,000 and a large daytime transient population serving approximately 2000 retail and industrial-based businesses.

The Elmhurst Police Department began its relationship with motorcycles in 1920. Motorcycles were some of the first motorized vehicles used by law enforcement. Ever since the Twenties, Elmhurst has found a use for motorcycles in its fleet in one form or another. The department's motorcycle program has always kept in step with the times. Prior to 1950, side car motorcycles were used. In the 1950's and 1960's three wheeled units were used for parking and regular patrols. In the 1970's unmarked dirt bikes were used to patrol the Illinois Prairie Path (Great Western Trail) and numerous city parks. The early 80's saw significant growth in the motor officer program with the purchase of five 500cc Honda motorcycles to offset the first "gas crunch."

The late 80's brought about the purchase of two Harley-Davidson® motorcycles. A strong relationship has ensued between the Elmhurst Police Department and Harley-Davidson®. Three different Harley-Davidson® models have been used in the past two decades, all serving the motor unit well. department is partial to our most recent models, Electra Glide® the FLHTIPI. These were acquired through the program lease via Woodstock, IL Harley-Davidson®. The motor units have been aftermarket equipped with state-of-the-art features, including an in-console

multi-band radio, rechargeable flashlight and cordless radar. Each motor unit is custom striped and detailed to match the department's patrol vehicles.

All motor officers must complete a training certification program. They perform the normal cadre of police duties, as well as leading parades and attending community events. With major expressways and state thoroughfares running through the city, the most beneficial uses of the motor units have been in the areas of traffic enforcement and public relations.

# Stafford Police Department, NJ celebrates 40 years

Stafford Police Department celebrates its 40<sup>th</sup> anniversary this year. Twenty of those forty years the Department has maintained a motor unit comprised of Harley-Davidson® motorcycles. The unit was formed in 1982 by Chief Larry D. Parker, Sr. and is currently comprised of 10 officers (5 primary, 5 secondary). The unit also includes two motorcycle instructors, Master Instructor SPO William Sillitoe and Instructor SPO James Cahill. Both instructors are trained and certified by the Maryland State Police.

The Unit has been officially recognized numerous times. Particularly noteworthy is a First Place finish in the Law and Order Magazine 1990 International Police Vehicle Design Competition, and also the May 2000 Department of Defense Regional Award for 1<sup>st</sup> Place "Best Overall Motorcycle Unit."

The motorcycles are purchased from Mills Harley-Davidson®, Burlington County, NJ and are replaced every two years.

The Unit is attached to the Patrol Division and is commanded by Captain Larry D Parker, Jr. The regular duties of the Unit include highway patrol, community policing functions, selective enforcement, parades, funeral details and special events.

Stafford has a geographic jurisdiction of 47.5 square miles and is a coastal municipality located in southern New

Jersey. The town houses a winter populace of 24,000 and a summer populace of 50,000.

Needless to say, the motorcycle unit is a great officer morale builder, an immeasurable contribution to the Police Department's overall public image and an invaluable tool in the Agency's tool chest to accomplish the police mission.

# First Annual All-Delaware Motorcycle Training Day and Skills Competition

n May 7th, the Newark and Seaford Police departments hosted the First Annual All-Delaware Motorcycle Training Day and Skills Competition at the Newark Police **Department** Headquarters. Fifteen riders from throughout Delaware spent a full day of refresher training and tight competition. Sergeant Robert Lee of Seaford PD and Lieutenant Thomas Le Min of Newark PD served as instructors and judges for the event. Officers were joined by Mr. Steve Greggins, the shop supervisor for Mike's Famous Harley-Davidson®, who provided mechanical support and answered technical questions throughout the day.

Training included a variety of braking and rapid lane change exercises, formation riding, curb pullouts and cone courses. After a morning spent conducting drills and negotiating cone patterns, the officers traveled to neighboring Maryland and Pennsylvania to refresh their group riding skills, hand signals and obstacle avoidance.

The high point of the day came in the afternoon when officers competed

for the titles of Best Individual Motor Officer and Best Motor Officer Team. Solo officers completed a timed cone course for which they were penalized points for both cone touches and foot touches. At the completion of the individual rider portion, officers simultaneously competed in pairs along the same timed course, simulating the response of a pair of motor officers to an emergency call.

In the end, PFC Marc Whitney of Seaford Police Department took

home the Best Individual Motor Officer trophy with a time of 1:36. Senior Corporal James Morton and Patrolman Greg Malesich of the Delaware River and Bay Authority Police Department won the Best Motor Officer Team title with a time of 1:41, barely edging out Seaford Police Department by a mere 2 seconds. Trophies for the skills competition were generously donated by Mike's Famous Harley-Davidson® of New Castle, Delaware.

# **6th Annual Gulf Coast Police Motorcycle Skills Championship**

#### Sponsored by the Baton Rouge Police Department Traffic Division

**November 5-8, 2003** 

The Baton Rouge Police Traffic Division will be hosting the 6<sup>th</sup> Annual Gulf Coast Police Motorcycle Skills Championship in Baton Rouge, Louisiana, November 5-8, 2003. This even benefits the Dream Day Foundation, which supports St. Jude's Children's Hospital.

Training and practice will take place November 5-7, 2003, on a closed cone course designed to simulate maneuvers and emergency situations faced by motorcycle officers during their tours of duty. Four local instructors, along with a number of visiting instructors, will be on-site to help officers hone their skills and learn new methods of safely avoiding crashes and advanced motorcycle-handling techniques.

On Saturday, November 8, 2003, a timed competition will be held and this will be open to the general public. Last year, nearly 150 officers from twenty departments in nine states competed. Participants will be given complimentary breakfast, lunch and dinner on November 5-8, 2003 and the entry fee will include one ticket

for the participant to attend the awards banquet Saturday night.

Actual course information shall be available by request only in late August. If you wanted to ride a motorcycle you would be evaluated by a police officer on the city streets and the officer would pass or fail you." Officer Weast led all of the parades in the city until he left. Charlie Cotter then took over his duties. The Chief of Police in Waukesha at that time was Harold Owens, who went on to become the mayor.






